



## 2023-2024 Club Ministries Policies and Releases

**Emergency/Consent to Treat Release.** I hereby authorize the Club Ministry Staff to render first aid and/or secure medical treatment s/he deems necessary for myself/my child/my family members if necessary. I give permission to professional medical personnel to provide routine health care, to administer prescribed medications, order x-rays, routine tests, treatment, to release any records necessary, and to arrange or provide medical transportation for my child/myself/my family member. If an emergency arises and the parent or guardian can't be reached, I hereby give my permission to the physician selected by the Club Ministry Leader to secure and render treatment, including hospitalization. I will be financially responsible for all costs incurred thereby, regardless of insurance coverage.

**Code of Conduct Policy.** Participants in any Club event are subject to the observance of the Seventh-day Adventist Program and Event Code of Conduct, as set forth below. The following behaviors and actions will not be tolerated at any Seventh-day Adventist event. Any participant who fails to comply with this policy will be subject to discipline as deemed appropriate by event staff members.

- Abusive language towards a staff member, volunteer, or another participant at the Club event.
- Possession or use of alcoholic beverages, tobacco, vapes and/or juuls, or illegal drugs at any Club programs or events.
- Coming to any such programs or events while under the influence of drugs or alcohol.
- Bringing to any such programs or events dangerous or unauthorized materials such as explosives, firearms, or weapons
- Discourtesy or rudeness to a fellow participant, staff member, or volunteer.
- Verbal or physical harassment of another participant, staff member, or volunteer.
- Actual or threatened violence toward any individual or group.
- Conduct endangering the life, safety, health, or well-being of others.
- Bullying or taking unfair advantage of another participant.
- Failing to cooperate with a staff member.

Seventh-day Adventist reserves the right to dismiss a participant from any Club Ministry programs or events upon a violation of the above-listed behaviors or actions, as well as under circumstances where the participant's conduct is dangerous, illegal, or detrimental to the event or other participants safety. Illegal conduct may also result in the reporting to, as required by applicable laws or Seventh-day Adventist policies, and/or intervention by law enforcement.

**Photo Release.** I am aware that photos/videos may be taken of myself/my child/my family members at Ministry Events. I grant the Seventh-day Adventist Church and their subsidiaries full permission to use images, recordings and any other record of myself/my child/my family member while participating at Club Ministry Events without compensation, including use for promotional purposes.
