- 2. Donations for 2020 totaled \$30,114.54 and that for 2021, \$32,360.45. This represents 7.5 % increase from 2020 to 2021.
- 3. There is a 56.7% increase in closing bank balance.
- 4. Rental is for MAPM's main P.O. Box 236, Elk River, MN 55330. Rental increased from \$105 to \$134.
- 5. Total expenses decreased by 7.3% between 2020 and 2021 CBB expenses being the main contributor as usual.
- 6. \$15.54 in tithes were received for 2020 from Offenders but none in 2021.
- 7. Bank balance as of September 30, 2022 \$ 24,623.07: CBB \$2,191.61; Books/Bibles/DVDs \$10,101.31; General Funds \$11,864.98; Baptistery \$ 95.00; Study Bibles \$370.17
